We have ***increased our Family Support operations*** with an injection of funds from the Department of Human Services and our Caroline Springs site is a home for many of our family support case workers and we are building a group of volunteers and donors of material aid. Moonee Valley residents will soon notice ***41 Park Street*** on the market. For some years, the site has not been suitable for our personal style of work in a more heavily regulated environment. The Board undertook some analysis and an upgrade to Park Street that might achieve our objectives is not financially viable. The Society plans to ***retain a physical presence in the Moonee Valley area***. The location of such a presence will depend on the market and our objective which is to offer pregnancy and family support that includes onsite counselling and appointments for material aid and emergency relief.

An interview with Board Member, Frank Smit

When did you join the Caroline Chisholm Society?

About 1970. Pauline [Frank's wife] was on the phones the first day we had the telephone counselling line running. She'd had training prior to that. When the society was Incorporated in 1974, I was the first President. Mary Hoban, who we'd asked to be the President, was overseas and hadn't yet become a member of the incorporated society.

What's your role at the Society?

I've held every job on the committee with the exception of Assistant Secretary. At the moment, I'm Secretary. That involves being the Company Secretary and requires me to be accountable to the Australian Securities and Investments Commission (ASIC) on

behalf of the Society.

What is the most rewarding thing about that role?

Being able to keep the running of the Society on track from financial, legal and day to day running perspectives.

What moment is your favourite memory of the organisation?

Helping to shift people from one end of town to the other and losing quarter of the load of the trailer in the middle of Malvern Road and High Street at 9pm in the rain. ***Did you laugh or cry, Frank?*** I just got out and put it back on the trailer.

Who were you helping?

A client who'd been evicted from a house in the east and needed

to move to a flat in Flemington. I'd arranged two volunteers to load and a different two to arrive at the other end.

So you were on your own in that big intersection, with trams and cars going everywhere, with a lost load on your own?

Yeah. Apart from that, in the early days on a number of occasions we had pregnant women stay at our place for various lengths of time, and we had some members of the Society stay too. One could say, in the early days, it was absolutely hands on for all members.
